Challenge Instructions

The following outlines the instructions for completing and submitting an entry for the 2023 Flood:ED Challenge:

- 1. In order to give your learners the necessary knowledge and skills to complete the challenge, we highly **recommend** completing a selection of the following learning activities:
 - i. Flooding Mapping Tour
 - ii. Understand Flooding
 - iii. What are Floodplains and Watersheds?
 - iv. Flooding and Climate Change
 - v. <u>Flood Risk Management Awareness: Learnings from Past</u> Disasters
 - vi. Runoff Footprint
- 2. Plan **or** act for flood resilience. Becoming flood resilient can take many forms. We can develop plans and strategies to better prepare for floods, or we can take action that helps reduce the impacts of floods.
 - a. **Plan** for flooding events by developing a Flood Resilience Plan for your school.
 - i. Use the <u>Flood Resilience Plan Worksheet</u> to help guide you through putting together a flood resilience plan for your school.

OR

- b. **Act** for flood resilience by taking any given actions linked below to combat flooding or choose your own!
 - i. Complete <u>Act to Combat Flooding Worksheet</u> to show us the actions you took to combat flooding in your school and the impact of your actions!
- 3. Share your learning, planning or action on social media, with your family and in your school community. Don't forget to tag @GreenLearning on Twitter, Instagram and Facebook.
